What are cookies and other similar storage technologies?

On Biltema Suomi Oy AB, org. nr 556297-3320, the (Biltema) website below, cookies and other similar storage technologies are used.

Cookies are small text files stored on the visitor's computer. Other storage technologies (such as pixels) are used for similar purposes and enable cookie recognition and other types of device identifiers. Cookies enable Biltema to follow what visitors do on our website, make our website work more efficiently, and personalize the website's content and relevant marketing through other platforms.

There are two main types of Cookies: permanent cookies that remain on your computer for a certain period of time before being deleted, and session cookies that are stored temporarily in your computer's memory while you are on a web page. Session cookies disappear when you close your browser.

Cookies may be sent to you either from the website you visit (so-called first-party cookie) or from another organization that delivers services to the website you visit, such as an analytics and statistics companies, resellers, social media, marketing companies, etc. (so-called third-party cookie). To improve your experience of our website, Biltema allows third-party cookies. Third-party cookies are set by third parties and used by them. For more information about their cookie usage, please refer to the respective company's cookie policy.

Permanent Cookies are used, among other things, to store visitors' personal settings with Biltema so that you as a visitor e.g. do not have to make certain choices every time you visit the website and to customize and make information as relevant as possible. Session cookies are used, among other things, for the purpose of recording statistics on the use of the website.

Biltema also uses server-side tracking for analysis and marketing purposes. This means that certain events on the website are first collected via technology on the website and can then be forwarded via a server-based solution provided by Stape on behalf of Biltema to our analysis and marketing partners.

The purpose of this solution is to improve measurement, attribution, data quality and the ability to evaluate the effect of our marketing efforts in different markets. This technology does not change which categories of cookies are used, but means that in some cases the collected information is processed and forwarded via a server-based solution before being shared with the relevant partner.

Definitions

This cookie policy uses the following definitions.

"Cookie" is the cookies and other storage technologies used on the website for similar purposes.

"Partners" are companies approved by Biltema that have entered into agreements with us to sell and provide their products and services through the Website.

The "website" includes the biltema.xx website and related pages biltema.com.

How do we use Cookies?

Biltema stores certain Cookies on your device that are necessary to use the website. For other purposes, your consent is required.

Biltema uses Cookies to improve the experience of the website and for the following purposes;

- Safety
- For analysis and statistics
- To personalize the website
- To target ads and create relevant audiences for marketing purposes on the website, with our marketing partners and social media.

For analysis and marketing purposes, Biltema may also use server-based tracking. This means that information related to your visit, interactions and completed conversions may be processed in a server-based solution before being shared with our analysis and marketing partners.

This processing is used to improve the reliability of measurement and reporting, reduce loss of measurement data and improve the quality of conversion data.

Necessary

Necessary Cookies (also called Functional Cookies) allow you to use the website by enabling basic features and technologies, such as page navigation, the login procedure to personal accounts or whatever you have chosen to place in your shopping cart. The Website cannot function as intended without these Cookies and this type of Cookie does not collect information about what you as a visitor search for or look for on the Biltema website.

Security

We use Cookies to manage, protect both Biltema and the visitor and develop our systems and services safely and securely.

Analysis and statistics

Analytics and statistical cookies are used to facilitate analysis of the number of visitors to the website and to improve the customer experience when you visit our website, etc. This means that we may share and transfer personal and other information. Please note, however, that we do not process, share or transfer sensitive personal data.

Biltema may use both client-based and server-based measurement for these purposes. This means that certain information about how the website is used may be collected on the website and then processed in a server-based solution before being shared with our analytics providers.

Personalization

Personalization Cookies provide us with information about how you use our website, your purchasing history, what content you have sought and are interested in, etc. in order to offer you a more relevant experience of our website tailored to your preferences. This means that we may share personal and other information. Please note that we do not process, share or transfer sensitive personal data.

Marketing

We use cookies and similar technologies to display advertisements, campaigns, communications and offers that we believe are relevant to you. For this purpose, we may share and transfer personal data and other information to our marketing partners.

Biltema may also use server-based tracking to forward information about, for example, page views, interactions and conversions to platforms for advertising and measurement.

To improve the quality of our conversion measurement, Biltema may also use so-called enhanced conversions. This means that customer data that you provide yourself in connection with, for example, purchases or forms, such as email address, telephone number or address information, may, where applicable, be converted, for example by hashing, into a protected technical format before being shared with the relevant platform to improve matching, attribution and measurement of conversions. Google's documentation describes Enhanced Conversions as a function for improved conversion measurement with hashed first-party data.

We do not process, share or transfer sensitive personal data for these purposes.

Privacy Policy - Categories of personal data and information

This Privacy Policy applies Biltema Suomi Oy when Biltema Suomi Oy provides services and products in conjunction with purchases, customer service, and all other forms of contact, such as visiting the website and stores, and in order to fulfil our obligations to you as a customer.

Collaboration, marketing and analytics partners (third-party cookies)

Biltema uses partners for analysis, advertising, conversion measurement, personalization and functionality on the website. Sharing information with such partners can take place both through cookies and similar technologies in the browser and through server-based tracking. For this server-based solution, Biltema uses Stape as a provider of a server-based container solution. Through this solution, certain information about visits, interactions and conversions can be processed and forwarded to relevant analysis and marketing platforms on behalf of Biltema.

Biltema also collaborates with companies that provide products and services via the website. Some of these solutions may consist of so-called iframes, i.e. content from websites other than Biltema's own domains that is displayed on Biltema's website. Biltema cannot fully influence or control the content of such solutions, and we therefore refer to the respective provider's privacy policy in these cases. Examples of such solutions are YouTube clips and payment service providers.

It is important to know that third-party cookies from, for example, payment service providers can play an important role in enabling you as a visitor to complete and complete the payment process at the checkout stage when purchasing products on the website online.

Biltema also uses a first-party cookie to store a technical identifier that supports server-based tracking, measurement and attribution. This cookie is used to create and store a technical identifier that makes it possible to improve the quality of analytics and marketing measurement over time.

The cookie does not contain information that directly identifies you as a person, but it can be used as a technical identifier in combination with other information collected in connection with your visit or interaction with our services.

When this cookie is used for analytics or marketing purposes, it is stored in accordance with the choices you make in our cookie settings.

Biltema also uses Stape as a provider of a server-based container solution for analytics and marketing purposes. Through this solution, certain information about visits, interactions and conversions can be processed and forwarded to relevant analysis and marketing platforms on behalf of Biltema.

If you use a PC, cookies can be deleted using the keyboard shortcut [CTRL]+[SHIFT]+[Delete].
